You may continue to interview for employment until the expiration date listed on your letter of intern eligibility. However, during this period you must meet all attendance requirements at your assigned fieldwork (student teaching) site. A 30-day substitute or long-term substitute teaching position does not qualify as an internship.

By signing/submitting this form, I understand that this university internship credential will only remain valid while I am enrolled in the credential program coursework appropriate for the intern credential, maintain employment at the designated district, and remain in good standing with the program and university.
